Maidstone Sports Awards

On the 27th of January 2012 following an invitation, the Secretary will attend the above awards held at the Leisure Centre Maidstone. Several prestigious awards will be made to local sportsmen and women in the County. **Minister for Sport, Hugh Robertson MP** will also be attending with other County Representatives. The Charity has sponsored the event and the **Secretary will present an award for the Best Club of 2011.**

Grants

Several grants have been made recently and include **St Mary's Boxing Club** in Chatham. Sadly the sale of the club's premises after 70 years has forced changes at the club. They have now purchased land at Shipwright's Avenue, the site of the former Scouts Hut and are seeking funds to develop the plot into Kent's Regional Boxing Centre. The Trustees have **awarded a grant of £1000** to the project. **A grant of £1000** was also pledged to **West Farleigh Sports Club** to assist with the replacement of changing facilities at Charlton Lane. The club has also received confirmation of a £25,000 grant from Sport England which shows there is still money out there if your application meets the criteria. **Deal Victoria & Barns Close Cricket Club** has also been **awarded a grant of £1000** to assist with the cost of laying a new artificial wicket at their ground at Gun Meadow in Deal. Further applications will be considered in February next year.

Pre Olympic Boxing Event

On the evening of Friday 25th November the Secretary attended the **ExCel Centre in London Docklands** to see the final preparations for the **Olympic Boxing Tournament.**

The arena provides ample space for up to 6000 spectators for the finals with huge viewing screens at each side of the ring.

Although a dress rehearsal for the main event, international matches had been arranged with several bouts taking place throughout the afternoon and evening sessions. The standard of refereeing was very good and consistent, matched only by the high class of boxing expected of athletes representing their home countries. Our thanks to **James Cullen, Kent's Boxing development Officer** and the **Amateur Boxing Association of England** for making the visit possible.

The Secretary also spoke with several representatives of the **English Table Tennis Association** about their plans for the finals at Excel and was again impressed by the sheer scale of the event, the numbers expected to attend and by the dedication and commitment of those supervising the Table Tennis. The venue is huge and has the capacity to accommodate 9000 spectators, indeed the facilities at ExCel are excellent and those lucky enough to have tickets for the Olympics are fortunate.

Change in inheritance Tax laws encourages charitable giving

The Chancellor recently announced a cut in the rate of inheritance tax from 40% to 36% from next April for those who left at least 10% of their estates to a good cause. Inheritance tax is only paid on estates worth more than £325,000. Currently therefore, an estate of £1m would see the beneficiaries receive £730,000 and the taxman £270,000. However, if 10% of that estate above the threshold is given to Charity, the beneficiaries would only receive £713,000 and the taxman £218,700. It means the charity receives £67,500. George Osborne said, "if you leave 10% or more of your estate to charity, then the Government will take 10% off your inheritance tax rate. I want to make giving 10% of your legacy to charity the norm in our country". The Charity is currently examining the possibility of providing a deed of Codicil for potential donors to simplify the process of Legacy Donations. The Stanley Blow & Ole Kverndal Awards

- **Applications for the above awards are invited and should be with the Secretary no later than 20th March next year.** Successful candidates will receive awards at the AGM at Tonbridge Castle on Wednesday 25th April 2012. **Application forms may be downloaded from the Association website www.kentpfa.org.uk or by contacting the Secretary.**
- Applicants must be sporting organisations or organisations promoting a sporting initiative in Kent. Applications will not be considered from public bodies or individuals.
- Qualifying schemes must be initiatives providing additional sporting opportunities for young people.
- Examples of qualifying schemes – coaching courses to develop sporting skills, courses for aspiring officials within a sport, competitions, and provision of items of non-personal equipment aimed at developing skills.
- There will no restriction on qualifying sports.
- The beneficiaries must generally be between the ages of 10 and 16 years. The maximum grant payable will be £300

We have now been informed unfortunately that neither Luca Russo nor Lloyd Milner has been successful in the final deliberations.
